life-saving temporary shelter

Domestic Violence Safe Temporary Overflow Program (DVSTOP) provides short-term emergency placement at a confidential location to domestic violence victims and their children when Maricopa County domestic violence shelters are full.

The program provides a critical service, offering community resources, shelter placement, and expedited services for those at highest risk. For immediate assistance, call the hotline below:

DVSTOP operates 24/7, 365 days a year; assisting women, children, and men in crisis at all times. Clients typically stay with DVSTOP for one to two days before moving into longer-term, safe housing. This may be at one of A New Leaf's shelters, or a partner.

Those fleeing to DVSTOP are housed in a temporary location and provided basic needs for a short-time, until longer-term shelter or housing can be found. It serves as a necessary community resource, providing callers with crisis intervention, resources, and referrals.

Services are available for adult victims of domestic violence and adult victims with children who are in need of shelter. Notably, DVSTOP also serves individuals and families that are difficult to place in domestic violence shelters such as: late-term pregnancies, disabled individuals, large families, and men.

If you are in an emergency situation, please call 911.

Call the 24-hour hotline **(480) 890-3039** or **1-844-SAFEDVS**. Trained operators assess the level of danger and determine which resources would be the most helpful to the caller.
