## life-saving services

**A New Leaf's Autumn House is a 22-bed domestic violence shelter providing security and shelter to women, children, and men fleeing abuse.**

Meant to provide a safe haven as families and individuals recover from the trauma of abuse, Autumn House offers comprehensive services to assist with obtaining and sustaining an independent, safe lifestyle. Autumn House provides full apartment-style units with kitchens, living rooms, and a nearby, fenced-in playground. Women, children, and men may stay up to 120 days, with referrals to additional services to ensure housing stability.

When a survivor arrives, safety is the top priority. Dedicated staff members are immediately assigned to support survivors. Services include referrals, safety planning, empowerment classes, case management, goal setting, legal advocacy, employment assistance, and financial literacy classes.

Autumn House serves anyone who is a victim of domestic violence, regardless of gender. All clients are screened prior to placement in Autumn House. Clients must not be local residents to ensure security; local residents will be given temporary shelter and then will be transferred to a different location. To receive assistance, please call Maricopa County's 24-hour Domestic Violence hotline at **(480) 890-3039** or **1-844-SAFEDVS**, or email staff at **dvstop@turnanewleaf.org**.

Trained operators immediately assess the level of danger and determine which resources would be the most helpful to the caller. Every caller is assisted according to their needs. Some callers receive immediate police assistance, and others work with the operator to build a safe exit plan.

## pet services

At Autumn House, we provide a safe, welcoming space for survivors of domestic violence and their pets. We know how important it is to keep your family together, so cats and dogs of all breeds and sizes are welcome.

Pets stay with their owners, and we offer free pet supplies. For cats, we have a dedicated sitting room when owners need to leave the site. To ensure safety and comfort, we allow **1-2 pets per unit**, depending on breed and behavior.
